Hold Harmless Agreement

This HOLD HARMLESS AGREEMENT (this "Agreement") is made effective between A New Vision Leadership Foundation of Acadiana (hereinafter, "New Vision Leadership"), of 217 Piave Street, Lafayette, Louisiana 70501 and New Vision Leadership Parents, Mentors, Board of Directors, Youth Members, and Volunteers (hereinafter, "Recipients of New Vision Leadership Services"), of Lafayette, Louisiana.

A New Vision Leadership Foundation of Acadiana and the Recipients of New Vision Leadership Services are sometimes individually referred to as "Party" and collectively referred to as the "Parties."

WHEREAS Recipients of New Vision Leadership Services desires to hold harmless New Vision Leadership from any claims and/or litigation arising out of Recipients of New Vision Leadership Services' actions in connection with any actions, other than criminal, that take place enroute or during any event, meeting, or service provided by New Vision Leadership.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, New Vision Leadership and Recipients of New Vision Leadership Services hereby agree as follows:

TERMS

1. Hold Harmless

Recipients of New Vision Leadership Services shall fully defend, indemnify, and hold harmless New Vision Leadership from all claims, lawsuits, demands, causes of action, liability, loss, damage and/or injury, of any kind whatsoever (including without limitation all claims for monetary loss, property damage, equitable relief, personal injury and/or wrongful death), whether brought by an individual or other entity, or imposed by a court of law or by administrative action of any federal, state, or local governmental body or agency, arising out of, in any way whatsoever, any acts, omissions, negligence, or willful misconduct on the part of Recipients of New Vision Leadership Services, its officers, owners, personnel, employees, agents, contractors, invitees, or volunteers . This indemnification applies to and includes, without limitation, the payment of all penalties, fines, judgments, awards, decrees, attorneys' fees, and related costs or expenses, and any reimbursements to New Vision Leadership for all legal fees, expenses, and costs incurred by it.

2. Authority to Enter Agreement

Each Party warrants that the individuals who have signed this Agreement have the actual legal power, right, and authority to make this Agreement and bind each respective Party.



3. Amendment; Modification

No supplement, modification, or amendment of this Agreement shall be binding unless executed in writing and signed by both Parties.

4. Waiver

No waiver of any default shall constitute a waiver of any other default or breach, whether of the same or other covenant or condition. No waiver, benefit, privilege, or service voluntarily given or performed by a Party shall give the other Party any contractual right by custom, estoppel, or otherwise.

5. Attorneys' Fees and Costs

If any legal action or other proceeding is brought in connection with this Agreement, the successful or prevailing Party, if any, shall be entitled to recover reasonable attorneys' fees and other related costs, in addition to any other relief to which that Party is entitled. If it is the subject of dispute, the court or trier of fact who presides over such legal action or proceeding is empowered to determine which Party, if any, is the prevailing party in accordance with this provision.
